#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Nabin Goud, AT- Kutingpdar, Po- Kerukuda, Ps- Bhawanipatna, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 14.08.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-0220-3743 under SDO Elect. Kesinga.
- 2) As complained by the complainant abnormal bill was raised in the month of 02/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect, Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 03/09/2024
- 2) Bill details from March 2010 to July 2024
- 3) Date of supply 20/12/2009
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW

- 6) Meter No TWST1717025
- 7) Installed on 29/07/2024 with IMR: "0"
- 8) CMR: 12 KwH as on 03/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Consumer has cleared his dues up to 12/2020 by OTS.
  - Excess billing in the month of 02/2023.
  - Provisional bill not been adjusted from 04/2023 to 04/2024.
  - As per PVR submitted by Officer Commerce, Utkela on dated 03/09/2024 consumer has very low consumption.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- · The complainant reiterated for excess billing. The OP stated that the Consumer has cleared his dues up to 12/2020 by OTS. Excess billing in the month of 02/2023. Provisional bill not been adjusted from 04/2023 to 04/2024.
- As per PVR submitted by Officer Commerce, Utkela on dated 03/09/2024 consumer has very low consumption.
- As per billing database wrong meter reading was punched in the month 02/2023 and provisional bills were served from 04/2023 to 04/2024, Again meter reading was reset on 05/2024 with reading 1429, but no bill revision was done for the mistake.

### **ORDER** 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 11/2022 to 05/2024 with IMR "1309" KwH on 11/2022 and FMR "1429" KwH on 05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
