GIST OF THE COMPLAINT:

The complainant consumer Sri Thabira Sahu, At/Po-Gaigaon, Ps-Kesinga, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Utkela on dt. 16.09.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/GP supply with CD of 0.5 KW having consumer no- 9033-0221-0918 under SDO Elect. Kesinga.
- 2) As complained by the complainant that excess bill was served in the month of 10/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Excess billing raised from some months from 06/2022 to 10/2024. Bill revised in FG from 12/2020 to 10/2024. However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Excess billing raised from some months from 06/2022 to 10/2024. Bill revised in FG from 12/2020 to 10/2024
- Bill revision already take in place on dt-22.11.2024. so, no bill revision required.
