GIST OF THE COMPLAINT:

The complainant consumer Sri Dambrudhar Bhoi, At/Po- Laitara, Ps- Kesinga, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 17.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-0223-1215 under SDO Elect.
- 2) As complain by the complainant that the average bill was served from 01/2001 to
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Average bill from 01/2001 to October 2001, December 2002 to December 2003 and from January 2008 to September 2011.
 - A credit sundry amount of Rs. 21429.90 has been posted in the month of 03/2012.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that average bill from 01/2001 to October 2001, December 2002 to December 2003 and from January 2008 to September 2011.
- A credit sundry amount of Rs. 21429.90 has been posted in the month of 03/2012.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from Nov/Dec-2002 to Nov/Dec-2003 by taking 6 months average consumption with IMR "14" KwH on 01/2004 and FMR "140" KwH on 06/2004.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
