#### GIST OF THE COMPLAINT:

The complainant consumer Sri Basant Sahu, At- Brahmani, Po- Kandel, Ps- Kesinga, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 08.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-0223-5252 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the bill was raised without availing power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the bill was raised without power supply.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

1) PVR: 14/11/2024

2) Bill details from: 09/2018 to 10/2024

3) Date of supply: 01.08.2018

4) Category: LT/Domestic

5) Connected Load 1 KW



6) Meter No - TWSP51067958

7) Installed on: 13/11/2023 with IMR: "0"

8) CMR: 650 KwH as on 14/11/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Kesinga as follows:

Average bill (without meter) from 09/2018 to 09/2021

• As per PVR submitted by JE and officer com. Section officer Utkela on dated 14/11/2024, consumer was availing power supply from 13/11/2023 and before that he was not using power supply.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the average bill (without meter) from 09/2018 to 09/2021
- As per PVR submitted by JE and officer com section officer Utkela on dated 14/11/2024, consumer was availing power supply from 13/11/2023 and before that he was not using power supply.
- As per billing database the bill was served provisionally from 09/2018 to 09/2021 & the bill was served in 12/2023 for 27 months, which needs to be revised.

# ORDER 29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To withdraw the bill from 09/2018 to 09/2021 as the consumer was not availed the power supply.
- To revise the bill for the month of 12/2023 by taking six months average consumption of present meter (i.e. IMR "0" KwH on 11/2023 and FMR "187" KwH on 04/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
