GIST OF THE COMPLAINT:

The complainant consumer Sri Debara Goud, Repr. by Smt. Debaki Goud AT- Turla, Po- Sirol, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 17.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-0223-5945 under SDO Elect. Kesinga.
- 2) As complain by the complainant the the bill was raised during line disconnection period from 11/2019 to 09/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from 11/2019 to 082024
- 3) Date of supply 17/05/2019



- 5) Connected Load 1 KW
- 6) Meter No -TWSP51035566
- 7) Installed on 18/0/2023 with IMR: "0"
- 8) CMR: 2294 KwH as on 25/09/2024
- 9) The meter status: Disconnected
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Average billing from 11/2019 to 09/2021.
 - Provisional bill not been adjusted from 03/2022 to 08/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that Average billing from 11/2019 to 09/2021. And Provisional bill not been adjusted from 03/2022 to 08/2023.
- As per billing database average/provisional bill was raised from 05/2019 to 09/2023. And the consumer was paid Rs.500.00 on dtd.21.03.2020 and Rs.500.00 on 07.03.2021, it is understood that the complainant was using power supply from dtd.05/2019 to till date.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> As the complainant availing power supply from 05/2019, so no need to withdraw the bill.

The case is disposed of accordingly. The case is hereby dropped
