#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Durbadal Podh, Repr. by Sri Jaleswar Podh AT-Bahadurpadar, Po- Patharla, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9033-0224-2265 under SDO Elect. Kesinga.
- 2) As complained by the complainant the bill was raised prior to the power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the excess bill.

### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 8) CMR: "101" as on 08.08.2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - As per PVR given by Electrical section Officer and Officer commerce Utkela on dated 08/08/2024, the consumer was availing power supply from 01/02/2024 and before that consumer was not availing power supply.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that as per PVR given by Electrical section Officer and Officer commerce Utkela on dated 08/08/2024, the consumer was availing power supply from 01/02/2024 and before that consumer was not availing power supply.
- As per billing database the bill was raised provisionally from 03/2021 to 01/2024.

# **ORDER** 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To withdraw the bill from 03/2021 to 01/2024 as the consumer was not availing power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
