#### GIST OF THE COMPLAINT:

The complainant consumer Sri Rangapati Goud, At- Dangapakhan, Po- Borda, Ps- Borda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1301-1222 under SDO Elect. Kesinga
- 2) As complained by the complainant that abnormal bill was served from 04/2020 to 02/2025.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 21/03/2025
- 2) Bill details from: 11/2011 to 02/2025
- 3) Date of supply: 06/08/2011
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



6) Meter No - LW620183

7) Installed on: 28/03/2021 with IMR "0"

8) CMR: 9145 KWH on 21/03/2025

9) The meter status: OK

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Kesinga as follows:

 As per PVR submitted by JE Borda on dated 21/03/2025, the meter (LW620183) was installed on 12/2019 instead of 28/03/2021.

• In FG the bill has revised on meter changed from 04/2021 (28/03/2021) as per meter changed date in FG database.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per PVR submitted by JE Borda on dated 21/03/2025, the meter (LW620183) was installed on 12/2019 instead of 28/03/2021.
- In FG the bill has revised on meter changed from 04/2021 (28/03/2021) as per meter changed date in FG database.
- As per billing database some bill was raised in high consumption meter reading during the period from 04/2020 to 02/2025, which seems supress meter reading, and bill revision towards delay meter updating was take in place from 04/2021 to 06/2022, effect on dtd. 15/09/2022.

## ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 04/2020 to 02/2025 with IMR "0" KwH on 04/2020 and FMR "9138" KwH on 02/2025.
- > To withdraw the earlier bill revision was effect on dtd. 15.09.2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
