The complainant consumer Sri Hareram Bagarti, At/Po- Borda, Ps- Kegaon, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1301-2713 under SDO Elect. Kesinga
- 2) As complained by the complainant that some abnormal bill was served during the period from 11/2015 to 02/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that average bill from 01/2017 to 04/2018.
- As per billing database some bill was raised in high consumption meter reading during the period from 11/2015 to 02/2021, which seems supress meter reading.

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 11/2015 to 02/2021with IMR "0" KwH on 11/2015 and FMR "920" KwH on 02/2021.

The case is disposed of accordingly.
