

GIST OF THE COMPLAINT:

The complainant consumer Sri Kapurchan Nag repr. by Sri Manohar Nag, At-Dangapakhan, Po-Borda, Ps-Kegaon, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1301-3113 under SDO Elect. Kesinga
- 2) As complained by the complainant that average bill was served during the month of 10/2018 to 09/2019.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that average bill (without meter) from 10/2018 to 10/2019.
- As per billing database average bill was served from 10/2018 to 09/2019.

ORDER

29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 10/2018 to 09/2019 by taking average consumption of present meter (i.e. IMR "0" KwH on 09/2019 and FMR "1042" KwH on 08/2020).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
