GIST OF THE COMPLAINT:

The complainant consumer Sri Duanaik Mahara Repr. by Sri Umakanta Mahara, At/Po-Borbhata, Ps- Kegaon, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 25.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1302-1091 under EE, Elect. Sub Division Kesinga.
- 2) As complained by the complainant that abnormal bill was served during the period from 04/2013 to 06/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Kesinga) in its counter reply and course of hearing submitted as follows:

- 11) As written version submitted by EE, Elect. Sub Division Kesinga as follows:
 - Excess billing in the month of 12/2022.
 - From date of supply to 10/2016, the fixed cost has been charged in KTJ tariff.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess billing in the month of 12/2022.
- From date of supply to 10/2016, the fixed cost has been charged in KTJ tariff.
- As per billing database some bill was served in high consumption meter reading during the period from 04/2013 to 02/2023, which seems to suppress meter reading. And the average bill was served from 03/2023 to 06/2023 due to defective meter.

ORDER 02.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 11/2016 to 02/2023 with IMR "825" KwH on 10/2016 and FMR "4588" KwH on 02/2023.
- > To revise the bill from 03/2023 to 06/2023 by taking six months average calculation of present meter (i.e. IMR "0" KwH on 09/2024 and FMR "279" KwH on 02/2025).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>July-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
