**GIST OF THE COMPLAINT:**

The complainant consumer Sri Panchu Harijan, At-Borda, Po/Ps- Borda, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- **9033-1303-1529** under SDO Elect. Kesinga.
- 2) As complained by the abnormal excess bill in the month of 11/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 20/07/2025
- 2) Bill details from: 09/2015 to 06/2025
- 3) Date of supply: 18/02/2015
- 4) Category: LT/Domestic
- 5) Connected Load: 0.5 KW
- 6) Meter No – TWSP51215998
- 7) Installed on: 23.01.2025 with IMR "0"
- 8) CMR: 784 KWH on 20/07/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Excess billing in the month of 11/2022. However, the respondent requested the forum to take appropriate decision as necessary.

**FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:



- The complainant reiterated for excess billing.
- The OP submitted that the Excess billing in the month of 11/2022.
- Some abnormal bills were served during the period from 02/2015 to 09/2023 due to suppress meter reading.
- Meter no. TWSP51215998 had been installed on dt.23/01/2025 and the CMR is "784" Kwh as on dt.20/07/2025

**ORDER**  
**30.07.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- The bills to be recasted from 02/2015 to 09/2023 with IMR "0" Kwh on 02/2015 and FMR "8660" Kwh on 09/2023.

The case is disposed of accordingly.


Compliance report must be submitted to the Forum by August-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
