The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1303-1748 under SDO Elect. Kesinga
- 2) As complained by the complainant that the abnormal bill was served during the period from 04/2017 to 01/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:


To revise the excess bill.

11) As written version submitted by SDO Elect. Kesinga as follows:

Excess units billed in the month of 03/2019 and 07/2020.

Provisional bill not been adjusted from 03/2021 to 05/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess units billed in the month of 03/2019 and 07/2020.
- Provisional bill not been adjusted from 03/2021 to 05/2022.
- As per billing database some bill was served in high consumption meter reading during the period from 03/2017 to 01/2021.which seems supress meter reading.
 And average bill was served from 02/2021 to 06/2022.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 03/2017 to 01/2021 with IMR "0" KwH on 03/2017 and FMR "2563" KwH on 01/2021.
- ➤ To revise the bill from 02/2021 to 05/2022 by taking average consumption of present meter (i.e. IMR "1" KwH on 07/2022 and FMR "242" KwH on 01/2023).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
