**GIST OF THE COMPLAINT:**

The complainant consumer Sri Tino Harijan, At- Barfa, Po/Ps- Borda, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- **9033-1303-1755** under SDO Elect. Kesinga.
- 2) As complained by the complainant that the abnormal excess bill was served in the month of 06/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 20/07/2025
- 2) Bill details from: 04/2017 to 05/2025
- 3) Date of supply: 22.04.2017
- 4) Category: LT/Domestic
- 5) Connected Load: 0.5 KW
- 6) Meter No – TWSP51060750
- 7) Installed on: 16.10.2023 with IMR "0"
- 8) CMR: 619 KWH on 20/07/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Excess billing in the month of 06/2023 However, the respondent requested the forum to take appropriate decision as necessary.



### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the Excess billing in the month of 06/2023.
- Some abnormal bills were served during the period from 04/2017 to 07/2023 due to suppress meter reading.
- Meter no. TWSP51060760 had been installed on dt.16/10/2023 and the CMR is "619" Kwh as on dt.20/07/2025

### **ORDER**

**30.07.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:


- The bills to be recasted from 04/2017 to 07/2023 with IMR :0" Kwh on 04/2017 and FMR "4383" Kwh on 07/2023.


The case is disposed of accordingly.

Compliance report must be submitted to the Forum by **August-25** by the opposite party after compliance otherwise it will be treated as non-compliance.
