GIST OF THE COMPLAINT:

The complainant consumer Sri Ranjit Kumar Pradhan, Repr. By Smt Hemalata Naik, At-Gandabasa, Po-Dumuria, Via-Borda, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 13.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1303-1838 under SDO Elect. Kesinga.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 19/08/2025
- 2) Bill details from: 11/2018 to 07/2025
- 3) Date of supply: 10/2019
- 4) Category: LT/Domestic
- 5) Connected Load 0.5 KW
- 6) Meter No LW229127
- 7) Installed on: 01/10/2019 with IMR "0"
- 8) CMR: 7793 KWH on 19/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - As per PVR submitted by section Officer Borda on dated 19.08.2025, the consumer was availing power supply from 10/2019. Before that he was not availing power supply.



Bill revised from 11/2019 to 01/2022. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR submitted by section Officer Borda on dated 19.08.2025, the consumer was availing power supply from 10/2019. Before that he was not availing power supply. Bill revised from 11/2019 to 01/2022
- Some bill was served from 09/2019 to 07/2025 abnormally due to supress meter reading.

ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To withdraw the bill from 11/2018 to 09/2019 as the power supply was not given.
- To recast the bill from 10/2019 to 07/2025 with IMR "0" KwH on 10/2019 and FMR "7766" KwH on 07/2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>September-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
