#### **GIST OF THE COMPLAINT:**

The complainant consumer Kai Sabar Repr. by Sri Bhaskar Sabar, At- Barfa, Po- Dumuria, Ps-Borda, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1303-2190 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the abnormal excess bill was served in the month of 03/2023 and 08/2023 which were 3126 KwH and 2514 Kwh respectively.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 20/07/2025
- 2) Bill details from: 11/2019 to 06/2025
- 3) Date of supply: 12.02.2018
- 4) Category: LT/Domestic
- 5) Connected Load: 0.5 KW
- 6) Meter No TWSP51160756
- 7) Installed on: 13.06.2024 with IMR "0"
- 8) CMR: 318 KWH on 20/07/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Excess billing in the month of 03/2023 and 08/2023. Contra entry for previous bill revision has passed to withdraw the bill revision from 01/2023 to 07/2023. However, the respondent requested the forum to take appropriate decision as necessary.

# FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the Excess billing in the month of 03/2023 and 08/2023. Contra entry for previous bill revision has passed to withdraw the bill revision from 01/2023 to 07/2023.
- Some abnormal bill was served during the month from 02/2018 to 05/2024 due to supress meter reading.
- Meter No. TWSP51160756 had been installed on dt.13.06.2024 and the CMR is "318" KwH as on dt. 20.07.2025.

## ORDER 30.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> The bills to be recasted from 02/2018 to 05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>August-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
