#### **GIST OF THE COMPLAINT:**

The complainant consumer Smt. Purnami Sahu repr. by Sri Uttsab Sahu, At- Salegaon, Po- Sikuan, Ps- Kegaon, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1303-3088 under SDO Elect. Kesinga
- 2) As complained by the complainant that the abnormal bill was served during the period from 11/2020 to 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 8) CMR: 468 KWH on 21/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Date of supply is 01/11/2020. but first bill generated on 03/2023.
  - Excess units billed in the month of 03/2023, 04/2023.
  - Average billing in the month of 11/2023.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Date of supply is 01/11/2020, but first bill generated on 03/2023.
- Excess units billed in the month of 03/2023, 04/2023.
- Average billing in the month of 11/2023.
- As per billing database some bill was served in high consumption meter reading during the period from 11/2020 to 09/2023, which seems supress meter reading. After that average bill was served in the month of 10/2023 & 11/2023.

### ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 11/2020 to 09/2023 with IMR "0" KwH on 11/2020 and FMR "2039" KwH on 09/2023.
- To revise the bill from 10/2023 to 11/2023 by taking 6 months average consumption of present meter (i.e. IMR "0" KwH on 12/2023 & FMR "148" KwH on 05/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
