**GIST OF THE COMPLAINT:**

The complainant consumer Sri Kailash Baitharu, At-Kantamal, Po-Kuhura, Via-Borda, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 13.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9033-1304-0330** under SDO Elect. Kesinga.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 05/2011 to 07/2025
- 3) Date of supply: 20/05/2011
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No – TWST15026615
- 7) Installed on: 02/08/2025 with IMR "0"
- 8) CMR: 124 KWH on 20/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Average billing from the month 11/2013 to 07/2022. The bill has revised on meter changed from 11/2021 to 07/2022. However, the respondent requested the forum to take appropriate decision as necessary.



## **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Average billing from the month 11/2013 to 07/2022. The bill has revised on meter changed from 11/2021 to 07/2022.
- From 11/2013 to 07/2022 average bills have been served.

### **ORDER**

**30.08.2025**

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- The bills served from 06/2016 to 05/2018 are revised by taking average of six consecutive billing of old meter no-LW469038 with IMR "792" Kwh on 09/2022 and FMR "1130" Kwh on 05/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
