### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Bibhu Beshra, Repr. By Sri Manoj Beshra, At-Kantamal, Po-Kuhura, Via-Borda, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 13.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1304-1668 under SDO Elect. Kesinga.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 11/2012 to 07/2025
- 3) Date of supply: 29/10/2012
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No TWB600930
- 7) Installed on: 08/01/2024 with IMR "0"
- 8) CMR: 455 KWH on 20/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Excess billing in the month of 03/2023. However, the respondent requested the forum to take appropriate decision as necessary.



On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Excess billing in the month of 03/2023.
- Some bill was served from 10/2012 to 12/2023 abnormally due to supress meter reading.

**ORDER** 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 10/2012 to 12/2023 with IMR "0" KwH on 10/2012 and FMR "4637" KwH on 12/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by September-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
