The complainant consumer Late Laxmidhar Sahu Repr. by Sri Jagdish Sahu, At-Kantamal, Po-Kuhura, Ps-Kegaon, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1304-1767 under EE, Elect. SDO. Kesinga
- 2) As complained by the complainant that the abnormal bill was served during the month from 10/2012 to 08/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess units billed in the month of 03/2023 and 06/2024.
- As per billing database some bill was served in high consumption meter reading during the period from 10/2012 to 08/2024, which seems supress meter reading.

### ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 10/2012 to 08/2024 with IMR "0" KwH on 10/2012 and FMR "6353" KwH on 08/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
