The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1304-1913 under SDO Elect. Kesinga.
- 2) The Complainant submitted supress billing from 03/2023. Abnormal excess bill was served in the month of 03/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

To revise the excess bill.



FINDINGS / OBSERVATIONS OF THE FORUM



The complainant reiterated for excess billing.

Some abnormal bill was served from 09/2016 to 01/2024 due to supress meter reading.

Meter no. TWB121257 had been installed on dt.28/03/2024 and the CMR is "376" KwH as on dt.20/07/2025.

ORDER 30.07.2025

The OP is directed as follows:
