GIST OF THE COMPLAINT:

The complainant consumer Sri Bikram Barik, At/Po- Bargaon, Ps- Borda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 25.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1305-0209 under EE, Elect. Sub Division Kesinga.
- 2) As complained by the complainant that excess bill was served in the month of 05/2018.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Kesinga) in its counter reply and course of hearing submitted as follows:

1) PVR: 30/06/2025

2) Bill details from: 09/2013 to 05/2025

3) Date of supply: 20/09/2013

4) Category: LT/Domestic

5) Connected Load 0.5 KW

6) Meter No - TWB123323

7) Installed on: 07.04.2024 with IMR "0"

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. Sub Division Kesinga as follows:
 - Average and provisional bill not being adjusted from 11/2017 to 03/2018, in database it is showing that meter no- 102281 has been replaced with meter no WLT097862 in the month of 01/2018 whereas as per PVR submitted by JE Borda on dated 30/06/2025 meter no- 102281 is continuing from date of supply to 07/04/2024.
 - Excess billing in the month of 05/2018.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that average and provisional bill not being adjusted from 11/2017 to 03/2018, in database it is showing that meter no- 102281 has been replaced with meter no WLT097862 in the month of 01/2018 whereas as per PVR submitted by JE Borda on dated 30/06/2025 meter no- 102281 is continuing from date of supply to 07/04/2024.
- Excess billing in the month of 05/2018.
- As per billing database some bill was served in high consumption meter reading during the period from 09/2013 to 02/2024, which seems to suppress meter reading.

ORDER 02.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To recast the bill from 09/2013 to 02/2024 by taking IMR "0" KwH on 09/2013 and FMR "4700" KwH on 02/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>July-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
