## **GIST OF THE COMPLAINT:**

The complainant consumer Sri Gokul Barik, At- Bargaon, Po/Ps- Borda, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1305-0289 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the abnormal excess billing was served in the month of 11/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

## SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 8) CMR: 2370 KWH on 20/07/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga, as follows:
  - Excess billing in the month of 11/2021. However, the respondent requested the forum to take appropriate decision as necessary.



## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the Excess billing in the month of 11/2021.
- Abnormal bill was served in the month of 11/2021.
- Meter No. WHL040406 had been installed on dt. 01.11.2021 and the CMR is "2370" KwH as on dt. 20.07.2025

# **ORDER** 30.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> The bills served on 11/2021 is to be revised by taking average consumption of six billing of new meter (i.e. installed on dt. 01.11.2021 by taking IMR "0" KwH on 11/2021 and FMR "444" KwH on 05/2022).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by August-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
