### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Trinath Sahu, At- Phapsi, Po- Bargaon, Ps- Borda, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1305-0490 under SDO Elect. Kesinga
- 2) As complained by the complainant that the abnormal bill was served during the period from 03/2017 to 01/2022.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess unit bill in the month of 01/2022.
  - As per billing database some bill was served in high consumption meter reading during 03/2017 to 01/2022, which seems supress meter reading.

### ORDER

#### 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 03/2017 to 01/2022 with IMR "266" KwH on 03/2022 and FMR "2221" KwH on 01/2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 the opposite party after compliance otherwise it will be treated as non-compliance.
