GIST OF THE COMPLAINT:

The complainant consumer Sri Chhabimanyu Sahu, At/Po-Salebhata, Via-Borda, Dist.-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 13.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1306-0542 under SDO Elect. Kesinga.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 21/08/2025
- 2) Bill details from: 01/2019 to 07/2025
- 3) Date of supply: 01/2021
- 4) Category: LT/Domestic
- 5) Connected Load 0.5 KW
- 6) Meter No LW684942
- 7) Installed on: 17/01/2021 with IMR "0"
- 8) CMR: 2087 KWH on 21/08/2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - As per PVR submitted by section Officer Borda on dated 21.08.2025, the consumer
 was availing power supply from 01/2021. Before that he was not availing power supply.
 Bill revised from 01/2021 to 06/2023. However, the respondent requested the forum to
 take appropriate decision as necessary.



On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR submitted by section Officer Borda on dated 21.08.2025, the consumer was availing power supply from 01/2021. Before that he was not availing power supply. Bill revised from 01/2021 to 06/2023.
- From 01/2019 to 09/2021 Provisional / average bills have been served.

ORDER 30.08.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To withdraw the bill from 01/2019 to 12/2020 as the power supply was not given.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>September-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
