The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9033-1307-0427 under SDO Elect. Kesinga.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

## **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Average billing in the month of December 2004 to December 2006 and December 2008 to February 2013.
- Excess billing from October 2013 to May 2015.

## ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 04/2003 to 02/2007 taking IMR 0 as on 04/2003 and FMR 2958 as on 02/2007.
- To recast the bill from 09/2013 to 02/2021 taking IMR 0 as on 09/2013 and FMR 16421 as on 02/2021.

The case is disposed of accordingly.
