### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Hemanta Herna, AT- Khairmal, Po- Salebhata, Ps-Borda, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 14.08.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-1307-1087 under SDO Elect. Kesinga.
- 2) As complained by the complainant bill was raised without availing power supply.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from October 2020 to June 2022
- 3) Date of supply 15/12/2019
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



- 7) Installed on 14/12/2019 with IMR: N/A
- 8) CMR: N/A
- 9) The meter status: Ghost Consumer
- 10) Facts of the complainant: Withdrawn of bill.
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Consumer is not availing power supply and subsequently declared as ghost consumer on 06/2022.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Consumer is not availing power supply and subsequently declared as ghost consumer on 06/2022.
- As per PVR submitted by JE Borda that during physical verification no power supply at site and the consumer has been declared as ghost.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill raised from 12/2019 to 06/2022, as the complainant was neither availing power supply nor a consumer of the licensee.
- The complainant is directed to apply for new service connection in form 1 & 2 specified in rule 18 of conditions of supply code, 2019 of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
