GIST OF THE COMPLAINT:

The complainant consumer Sri Kanak Majhi, Repr. by Sri Goura Chandra Majhi, AT-Tepsa, Po- Palna, Ps- Kegaon, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 17.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9033-1308-0124** under SDO Elect. Kesinga.
- 2) Excess monthly average bill may be revise
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Average billing from 02/2015 to 05/2023.

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To revise the bill from 07/2021 to 06/2023 taking six-month average consumption new meter installed on 07/2023 taking IMR "0" KWH and FMR "61" Kwh as on 12/2023.

The case is disposed of accordingly.
