#### GIST OF THE COMPLAINT:

The complainant consumer Sri Bakhya Gahir, At/Po- Palna, Ps- Kegaon, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 25.06.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1308-0779 under EE, Elect. Sub Division Kesinga.
- 2) As complained by the complainant that the average / provisional bills were served during no power supply period.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

- 11) As written version submitted by EE, Elect. Sub Division Kesinga as follows:
  - As per PVR submitted by Section officer Borda on dated 30/06/2025, the consumer was availing power supply from 02/2020 before that he was not availing power supply.
  - Power supply was D/C in field soon after meter changed but punched in FG on dated 15/04/2024 and reconnected on 30/06/2025 after payment of Rs. 2998/- as per PVR.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR submitted by Section officer Borda on dated 30/06/2025, the consumer was availing power supply from 02/2020 before that he was not availing power supply.
- As per billing database average / provisional bill was served from 06/2018 to 04/2020.

## ORDER 02.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 06/2018 to 01/2020 as the consumer has not vailed the power supply during this period.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by July-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
