GIST OF THE COMPLAINT:

The complainant consumer Sri Bhagaban Jani, At- Tepsa, Po- Palna, Ps- Borda, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 12.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1308-0810 under SDO Elect. Kesinga
- 2) As complained by the complainant that the average bill was served from 06/2018 to 05/2020.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Average (without meter) from 06/2018 to 06/2020.
- Provisional bill not been adjusted from 08/2020 to 09/2023.
- As per billing database average bill was served from 06/2018 to 05/2020.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 06/2018 to 05/2020 by taking 6 months average consumption of present meter (i.e. IMR "0" KwH on 12/2023 and FMR "208" KwH on 05/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
