GIST OF THE COMPLAINT:

The complainant consumer Sri Chaturbhuja Nial, At/Po- Leter, Ps- Kegaon, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Borda on dt. 25.06.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1310-1030 under EE, Elect. Sub Division Kesinga.
- 2) As complained by the complainant that abnormal bill was served during the period from 07/2018 to 01/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub Division Kesinga) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. Sub Division Kesinga as follows:
 - As per PVR submitted by section office Borda on date 30/06/2025, the consumer was availing power supply from 02/2020 before that he was not availing power supply.
 - Excess billing in the month of 12/2021 and 12/2022.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR submitted by section officer Borda on date 30/06/2025, the consumer was availing power supply from 02/2020.
- Excess billing in the month of 12/2021 and 12/2022.
- As per billing database average/provisional bill was served from 07/2018 to 03/2023.

ORDER 02.07.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 07/2018 to 01/2020.
- To recast the bill from 07/2020 to 03/2023 with IMR "0" KwH on 07/2020 and FMR "3900" KwH on 03/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by July-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
