- The complainant has appeared before the forum for bill dispute / meter mismatch of his LT/Dom supply with CD of 1 KW having consumer No. 9033-1310-1064 under SDO Elect. Kesinga.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

To revise the excess bill.
