GIST OF THE COMPLAINT:

The complainant consumer Sri Seshadeb Patel, Repr. by Sri Rajindra Patel, AT-Makraguda, Po-Leter, Ps-Kegaon, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9033-1310-2079 under SDO Elect. Kesinga.
- 2) As complained by the complainant the abnormal bill was raised from 04/2023 to 07/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 12/08/2024
- 2) Bill details from October 2020 to June 2024



- 3) Date of supply 15/05/2018
- 4) Category: LT/Domestic
- 5) Connected Load 0.50 KW
- 6) Meter No TWSP51018925
- 7) Installed on 27/07/2023 with IMR: "0"
- 8) CMR: 501 KWH as on 12/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of abnormal bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Abnormal excess billing in the month of 04/2023 to 07/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that abnormal excess billing in the month of 04/2023 to 07/2023.
- As per billing database abnormal bill was raised in the month of 04/2023, which seems surplus meter reading. And provisional bill was raised from 05/2023 to 07/2023.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill by way of recasting from 05/2018 to 04/2023 with IMR "0" KwH on 05/2023 and FMR "4654" KwH on 04/2023.
- ➤ To revise the bill from 05/2023 to 07/2023 by taking six months average consumption of present meter (i.e. IMR "0" KwH on 07/2023 and FMR "227" KwH on 12/2023).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
