The complainant consumer Smt. Renu Naik, Repr. by Sri Abhisek Naik, At/Po-Tahasir, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9033-1401-0363 under SDO Elect. Kesinga.
- 2) As complained by the complainant excess bill amount has serve in the moth of 06/2023 and 07/2023 though the meter was running.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.
