#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Rajiv Naik, At/Po-Tahansir, Ps- Kesinga Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during the course of hearing at camp court at Kesinga on dt. 22.01.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/GP supply with CD of 10 KW having consumer no- 9033-1401-0889 under SDO Elect. Kesinga
- 2) As complained by the complainant that to change the billing tariff from LT/GP to LT/Agro Allied.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

  - As per ESO report consumer is availing power supply for poultry farm purpose.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the following:

- The complainant reiterated for excess billing.
- The OP submitted that as per ESO report consumer is availing power supply for poultry farm purpose.
- As per billing database the bill was generated in LTGP tariff from 10/2021.
- As per the report of the block veterinary officer, Kesinga vide Lt No. 189 dtd.01.06.2024 that Sri Rajiv Naik has started a boiler shed over the plot no. 226, Khata no. 225/23 of Mouza. Tahansir.

## ORDER 31.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from LT/GP to LT/Allied Agro tariff from 06/2024 onwards. And change the tariff from LT/GP to LT/Allied Agro category with immediate effect.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25, the opposite party after compliance otherwise it will be treated as non-compliance.
