GIST OF THE COMPLAINT:

The complainant consumer Sri Gajanan Agrawal, C/O MRF Tyre Show Room, At-Raghunath Pará, Po/Ps- Titlagarh, Dist.- Bolangir under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 19.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 2 KW having consumer no-9033-1401-1461 under SDO Elect. Kesinga.
- 2) As complained by the complainant the 2 Kw line has dismantled from pole meter has taken by the electrical department from since long time, the provisional bill has been served though the conductor of LT line has stolen by thief.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for withdraw the bill amount during line disconnection period. As the conductor of LT line has been stolen by thief.
- The OP stated that as per PVR submitted by JE, Electrical section office Nunmath on dated 18/10/2024, the supply line was disconnected on field from 03/2020.
- As seen from database, actual bill was generated upto 01/2020. When onwards all the bills were generated on provisional basis with house local remarks upto 07/2023 and the bill was stopped showing consumer as PDC.

ORDER 05.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill amount excluding the fixed charges from 03/2020 to 07/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
