- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Excess billing in the month of 02/2023.
- As per billing database 2026 units was billed in the month of 02/2023, which seems supress meter reading.

ORDER 30.09.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 11/2019 to 02/2023 with IMR "1450" KwH on 11/2019 and FMR "4473" KwH on 03/2023.

The case is disposed of accordingly.
