GIST OF THE COMPLAINT:

The complainant consumer Sri Bhurishraba Nayak, Repr. by Sri Krupasindhu Nayak, At/Po-Turlakhaman, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 21.02.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1402-2395 under EE, Elect. Sub-Division Kesinga
- 2) As complained by the complainant that the average bill was served from 08/2024 to 10/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub-Division Kesinga) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess bill on average basis from 08/2024 to 10/2024.
- As per billing database average bill was served from 08/2024 to 10/2024 due to meter defective. And the consumer was deposited Rs.10,000 on dtd.21.02.2025 for restoration of power supply.

ORDER 28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To restore the power supply and not to disconnect till resolve of bill dispute.
- ➤ To revise the bill from 08/2024 to 10/2024 by taking six-month average consumption of new meter installed on dtd.20.11.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>June-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
