- 2) As complained by the complainant that the bill has served in LT/GP category instead of LT/Domestic.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

To revise the excess bill.



## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per submitted by AOC section office Nunmath on dated 23.05.2025, the consumer has been using power supply in Domestic Purpose from 06/2023. Consumer has availed OTSS.
- As per billing database the bill has served in LT/GP from 12/2018 to 04/2025.

ORDER 31.05.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from LT/GP to LT/Domestic from 06/2023 to 04/2025.
- > To serve the bill in LT/Domestic category from 05/2025 onwards.
- The complainant is directed to pay the balance outstanding arrear as per regulation 144 of conditions of supply code 2019 of OERC.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>June-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
