The complainant consumer Sri Trilochan Majhi, Repr. by Sri Saroj Majhi AT- Masanibandha, Po- Balsi, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 17.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-1403-2172 under SDO Elect. Kesinga.
- 2) As complained by the complainant that 2242 unit was billed in the month of 08/2017.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

 - Excess billing in the month of 08/2017.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that Excess billing in the month of 08/2017.
- As per billing database 2242 units was billed in the month of 08/2017, which seems supress meter reading. And average bill was served from 07/2023 to 12/2023.

ORDER

28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 09/2013 to 06/2023 with IMR "0" KwH on 09/2013 and FMR "5086" KwH on 06/2023.
- > To revise the bill from 07/2023 to 12/2023 by taking six months average consumption of present meter (i.e. IMR "0" KwH on 01/2024 and FMR "178" KwH on 06/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
