GIST OF THE COMPLAINT:

The complainant consumer Sri Phalguni Gadtia repr. by Sri Kanhu Charan Gadtia, At- Bandpada Po- Tundla, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 21.02.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9033-1404-0753** under EE, Elect. Sub-Division Kesinga
- 2) As complained by the complainant that abnormal excess bills were charges in the month of 08/2024 and 09/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE, Elect. Sub-Division Kesinga) in its counter reply and course of hearing submitted as follows:

- 8) CMR: 62 KWH on 28/02/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by EE, Elect. Sub-Division Kesinga as follows:
 - Excess billing generated on average basis from 08/2024 to 09/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess billing generated on average basis from 08/2024 to 09/2024.
- As per billing database provisional/average bills were served and also 1451 and 1231 units were charged as an average billing for the month of 08/2024 and 09/2024. it indicates that the average bills were not served properly.

ORDER

28.02.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.


The OP is directed as follows:

- To revise the bill from 10/2023 to 10/2024 by taking six months average consumption of new meter installed on 03.11.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by May-25 the opposite party after compliance otherwise it will be treated as non-compliance.
