GIST OF THE COMPLAINT:

The complainant consumer Sri Surekha Bag, Repr. by Smt. Anandini Bag AT- Bandhapada, Po- Tundla, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 17.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-1404-0755 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the excess bill was raised from 07/2015 to 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/09/2024
- 2) Bill details from July 2015 to August 2024
- 3) Date of supply 18/05/2015



- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- 6) Meter No TWB123076
- 7) Installed on 05/05/2024 with IMR: "0"
- 8) CMR: 805 KwH as on 28/09/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Excess billing in the month of 07/2015 and 11/2023.
 - Provisional and average billing from 12/2023 to 01/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Excess billing in the month of 07/2015 and 11/2023. And provisional and average billing from 12/2023 to 01/2024.
- As per billing database 2152 units was billed in the month of 11/2023, which seems supress meter reading.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 06/2015 to 11/2023 with IMR "0" KwH on 06/2015 and FMR "5002" KwH as on 11/2023.
- To revise the bill for the month of 12/2023 to 01/2024 by taking six month average consumption of present meter (i.e. IMR "0" KwH on 02/2024 and FMR "623" kwH on 07/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
