GIST OF THE COMPLAINT:

The complainant consumer Sri Babulal Sahu, At- Bandhpada, Po- Tundla i, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nunmath on dt. 07.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1404-1615 under SDO Elect. Kesinga.
- 2) As complained by the complainant that bill was raised without power supply during the period from 05/2019 to 08/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Kesinga as follows:

 As per PVR submitted by JE Nunmath, on dated-21.0.2025, the consumer is availing power supply from 11/2023 and before that he was not availing power supply.

> An amount of RS. 8073.32 is debited and RS. 426.96 and RS. 792.39 are credited in consumer account for ghost consumer where balance is reflecting in, B4, B5 bucket dt. 23.02.2024 whereas the consumer is a live consumer. All the provisional bill has been adjusted.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per PVR submitted by JE Nunmath, on dated-21.0.2025, the consumer is availing power supply from 11/2023 and before that he was not availing power supply.
- An amount of RS. 8073.32 is debited and RS. 426.96 and RS. 792.39 are credited in consumer account for ghost consumer where balance is reflecting in, B4, B5 bucket dt. 23.02.2024 whereas the consumer is a live consumer. All the provisional bill has been adjusted.
- As per billing database provisional/average bill was served from 05/2019 to 08/2024. And the complainant was declared Ghost consumer by the licensee. The complainant was paid Rs.1000/- on dtd. 24.12.2023, which construe that the complainant was availing power supply on 12/2023.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 05/2019 to 11/2023.
- To revise the bill from 12/2023 to 08/2024 by taking 6 months average consumption of present meter (i.e. IMR "1" KwH on 09/2024 and FMR "185" KwH on 02/2025)

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
