The complainant consumer Sri Hemasagar Sa AT- Sanrapadar, Po- Parelsingha, Ps-Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9033-1405-0381** under SDO Elect. Kesinga.
- 2) As complained by the complainant that the provisional/abnormal bill was raised during the month of 09/2023 to 01/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

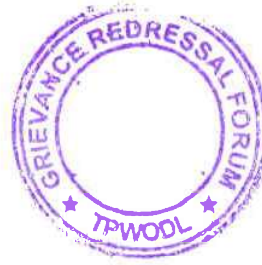
The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from January 2015 to July 2024
- 3) Date of supply 28/06/2013
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No – TWB649732
- 7) Installed on 12/02/2024 with IMR: "0"
- 8) CMR: 1171 KWH as on 22/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Abnormal billing from September 2023 to January 2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that Abnormal billing from September 2023 to January 2024.

ORDER

31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill by way of recasting from 10/2021 to 09/2023 with IMR "0" KWH on 10/2021 & FMR "7611" KWH on 09/2023.
- To revise the bill from 10/2023 to 01/2024 by taking six-month average consumption of new meter installed on 02/2024 with IMR "0" KWH and FMR "1189" KWH as on 07/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
