GIST OF THE COMPLAINT:

The complainant consumer Sri Baruna Patel, Repr. by Sri Bablu Naik, AT/Po-Parelsinga, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 18.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9033-1405-0650 under SDO Elect. Kesinga.
- 2) As complained by the complainant that Abnormal/Provisional/Average bill was raised during the month of 09/2023 to 12/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 22/08/2024
- 2) Bill details from February 2016 to July 2024



- 4) Category: LT/Domestic
- 5) Connected Load 1 KW
- Meter No TWB645675
- 7) Installed on 29/01/2024 with IMR: "0"
- 8) CMR: 514 KWH as on 22/08/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - Abnormal excess billing in the month of September 2023 of 6945 units.
 - Average billing from November 2023 to December 2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that abnormal excess billing in the month of September 2023 of 6945 units.
- Average billing from November 2023 to December 2023

ORDER

31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 01/2016 to 10/2023 taking IMR "0" KWH as on 01/2016 and FRM "8787" KWH as on 10/2023.
- > To revise the bill from 11/2023 and 12/2023 by taking six-month average consumption of new meter installed on 01/2024 with IMR "0" KWH and FMR "457" KWH as on 06/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
