The complainant consumer Sri Sunari Sunani, Repr. by Sri Girish Sunani, At- Podkham, Po- Sirol, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 08.11.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9033-1405-1359 under SDO Elect. Kesinga.
- 2) As complained by the complainant that the excess abnormal bill was served in the month of 10/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess billing in the month of 10/2023 and 08/2024.
- Average billing from 06/2024 to 07/2024.
- As per billing database the bill was raised in high consumption meter reading in the month of 10/2023 & 11/2023, which seems supress meter reading, and the average bill was served from 12/2023 to 08/2024 due to meter defective.

ORDER 29.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 11/2019 to 11/2023 with IMR "0" KwH on 11/2019 and FMR "1961" KwH on 11/2023.
- > To revise the bill from 12/2023 to 08/2024 by taking six-month average consumption of present meter installed on 18.09.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
