GIST OF THE COMPLAINT:

The complainant consumer Sri Gurubaru Sahu, At- Badipada, Po- Sirjapali, Ps- Kesinga, Dist-Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nunmath on dt. 07.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9033-1406-0053 under SDO Elect. Kesinga
- 2) As complained by the complainant that the meter was changed but the average bill was served instead of actual meter reading.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 30/03/2025
- 2) Bill details from: 08/2011 to 02/2025
- 3) Date of supply: 12/07/2011
- 4) Category: LT/Domestic
- 5) Connected Load 1 KW



- 6) Meter No WLT216684
- 7) Installed on: 27/09/2021 with IMR "0"
- 8) CMR: 5242 KWH on 30/03/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
 - As per PVR submitted by JE Nunmath on dated 30/03/2025. The meter no-WLT216684 was installed on 01/2019 instead of 27/09/2021.
 - Excess units billed in the month of 08/2022.
 - Bill has been revised from 02/2021 to 08/2021.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per PVR submitted by JE Nunmath on dated 30/03/2025. The meter no-WLT216684 was installed on 01/2019 instead of 27/09/2021.
- Excess units billed in the month of 08/2022.
- Bill has been revised from 02/2021 to 08/2021.
- As per billing database 2927 units was billed in the month of 08/2022 which seems to be suppressed meter reading.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 01/2019 to 02/2025 by taking IMR "0" kwh on 01/2019 and FMR "5226" kwh on 02/2025.
- To withdraw the upward assessment debited on dated 09/02/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
