### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Excess units billed in the month of 08/2017
- As per billing database some bill was served in high consumption meter reading during the period from 07/2011 to 08/2018, which seems supress meter reading.

## **ORDER** 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 07/2011 to 08/2018 with IMR "0" KwH on 07/2011 and FMR "5600" KwH on 08/2018.

The case is disposed of accordingly.
