# GIST OF THE COMPLAINT:

The complainant consumer Sri Adi Sahu, Repr. By Sri Bharat Sahu, At/Po-Sirjapali, Ps-Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 28.04.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9033-1406-0196 under EE Elect. SD, Kesinga.
- 2) As complained by the complainant that high unit's bill consumption was billed in the month of 08/2020 and 06/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE Elect. SDO, Kesinga) in its counter reply and course of hearing submitted as follows:

5) Connected Load 0.5 KW




7) Installed on: 26/08/2024 with IMR "0"

10) Facts of the complainant: Revision of bill



- Excess units billed for in the months of 08/2019, 08/2020, 02/20221 and 06/2021 as compared to consumer's regular consumption.
- Average bill from 08/2023 to 07/2024 has already been revised.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that excess units billed for in the months of 08/2019, 08/2020, 02/20221 and 06/2021 as compared to consumer's regular consumption.
- Average bill from 08/2023 to 07/2024 has already been revised.
- As per billing database some abnormal bill was served during the period from 10/2015 to 07/2023, which seems supress meter reading.

# ORDER 30.04.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 10/2015 to 07/2023 by with IMR "0" KwH on 10/2015 and FMR "2930" KwH on 07/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by May-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
