The complainant consumer Sri Dasarathi Gahir, Repr. by Sri Iswar Gahir, At-PO-Sirjapali, Ps- Kesinga, Dist.- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 27.05.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 1 KW having consumer no- 9033-1406-0261 under SDO Elect. Kesinga.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

To revise the excess bill.

- The complainant reiterated for excess billing. The OP stated that Excess billing in the month of December 2023.
- As per data base bill has already been revised on meter changed from 12/2019 to 04/2024 on date 31/05/2024.

ORDER 29.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

As EC bill has already been re-casted on 31/05/2024, so no further bill revision is

required. Hence the case is dropped.
