**GIST OF THE COMPLAINT:**

The complainant consumer Sri Chakra Nag, AT/Po- Pipalpadar, Ps- Kesinga, Dist- Kalahandi under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Kesinga on dt. 16.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- **9033-1406-0455** under SDO Elect. Kesinga.
- 2) As complained by the complainant that the average bill was served from 02/2009 to 01/2016.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the average bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Kesinga) in its counter reply and course of hearing submitted as follows:

- 5) Connected Load 1 KW

- 8) CMR: 1639 Kwh as on 19/12/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Kesinga as follows:
  - Average billing from 02/2009 to 01/2016.

### **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that Average billing from 02/2009 to 01/2016.
- As per billing database the average bill was served from 02/2009 to 01/2016 due to meter defective.

### **ORDER**

**06.01.2025**

Basing on the above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 02/2014 to 01/2016 by taking six-month average consumption of meter no. WCV57074 (i.e. IMR "0" Kwh on 02/2016 and FMR "178" Kwh on 07/2016).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by **January-25** by the opposite party after compliance otherwise it will be treated as non-compliance.
